



Guidelines for exhibitors & standbuilders

Due to the expected heavy traffic for World Hydrogen 2024 Rotterdam Ahoy has appointed **DB SCHENKER** for traffic management during buildup and dismantling. **DB SCHENKER** uses a time slot system for the purpose of keeping the traffic flowing. When the time slot system is active every motorized vehicle needs an access pass to enter the exhibition area. In addition, the time for being on site is limited in order to give all parties the possibility to load and unload:

- Vehicles below 7.5 tons (cars & vans) = max. 1 hour
- Vehicles above 7.5 tons (trucks) = max. 2 hours

During the 2024 build-up and breakdown, Ahoyweg will be one-way. Please use as navigation address: Jacob Kleiboerweg. Parking is permitted only in the spaces designated by traffic personnel. When the system is not active it is permitted to enter the premises for loading and unloading. Parking on the grounds is at Ahoy's expense.

House rules of Rotterdam Ahoy:

- Leaving the vehicle parked overnight is not permitted on the Ahoy premises.
- When detected, a fine of up to €500 per 24 hours may be charged according to Ahoy policy.
- Towing away regulation is in force.

This regulation and associated fine also applies to leaving vehicles behind during show days.

- Confirmation of the booking of your reservation will be send within two working days.
- Only employees of Schenker Logistics Nederland are authorized to deliver motorized or electric means of transport in the halls and outside spaces. The use of your own machines (portable forklift, forklift,aerial platform) is not permitted. Access for trucks with portable forklift on site is not permitted.
